# Paternity Preparation Checklist: Establishing Rights in Washington State

This checklist is for parents in Washington seeking to establish or challenge paternity and asking, "What documents do I need for paternity in Washington?" or "How do I prepare for DNA testing in Tacoma?" It helps organize information for efficient processes under <a href="Chapter 26.26A">Chapter 26.26A</a> RCW, potentially saving time/costs (average court case \$1,000-\$5,000). #### 1. Gather Basic Identification and Records

- Child's birth certificate: Obtain a certified copy from the WA Department of Health (~\$20 fee).
- Parents' IDs: Driver's licenses, passports, or birth certificates for both alleged father and mother.
- Marriage/divorce records: If applicable, to show presumption or prior status.
- Acknowledgment form: If voluntary, get a Paternity Acknowledgment from the hospital or DOH.

### 2. Prepare for Voluntary Acknowledgment (If Cooperative)

- Both parents' agreement: Discuss and prepare to sign the form together (free at DOH or hospital).
- Child's info: Full name, birth date, place for form completion.
- Witness/notary: Some forms require; arrange if needed.
- Post-signing updates: Plan for birth certificate amendment and benefit notifications.

#### 3. Prepare for Court Petition (If Disputed)

- Petition forms: Download Petition to Establish Parentage from the WA Courts site; complete with child/parent details.
- Financial declarations: Income/expense forms if support involved (e.g., for child support calc under Chapter 26.19 RCW).
- Evidence of relationship: Photos, messages, or affidavits from witnesses supporting paternity claim.
- Service documents: Prepare for serving the other party (fee \$50-\$100).

## 4. Plan for DNA Testing and Evidence

- DNA test info: Research accredited labs (cost \$300-\$500; state may cover if low-income).
- Medical records: Child's health history or prenatal care showing father's involvement.
- Timeline evidence: Dates of conception, birth, any prior acknowledgments.
- Challenge prep: If disestablishing, gather prior DNA or fraud proof within 4-year limit.

#### 5. Address Related Issues and Challenges

- Custody/support plans: Outline desired parenting time or support needs post-paternity.
- Background prep: Criminal/CPS records; address any issues early.
- Military considerations (JBLM): Deployment docs for SCRA delays.
- Financial budget: Estimate costs (filing \$260, attorney \$1,500+); check for waivers.
- Emotional support: List counselors or resources for family stress.
